Rule 13 – Procedures to Determine the winner of Play-off Matches

** Overtime & Penalty Kicks

1) In the event of a tie at the end of regulation time in:

a. An end of season playoff game (**FIRST ROUND, QUARTERS & SEMI FINALS**);

The winner shall be determined by:

i. Penalty kicks using a set of three (3) players from each team, who will take one kick each. Players may only be selected from among those on the field at the end regulation time.

ii. If still tied at the end of the above 3 kicks, penalty kicks in a sudden death format will continue until the game is decided.

2) In the event of a tie at the end of regulation time in:

a. An end of season playoff game (**FINALS**);

The winner shall be determined by:

i. 2 extra time periods of 5 minutes each whereby the “Golden Goal Rule” applies;

ii. If still tied, penalty kicks using a set of three (3) players from each team, who will take one kick each. Players may only be selected from among those on the field at the end of the second overtime period

iii. If still tied at the end of the above 3 kicks, penalty kicks in a sudden death format will continue until the game is decided.
